Regulations for Vendors

The 8th Annual Greynolds Park Love In will be held on Sunday, May 15, 2011. Hours will be from 11:00 AM to 6:30 PM. The Festival is conducted at Greynolds Park, located at 17530 West Dixie Highway, North Miami Beach, FL, 33160, 305-948-2891 or Email: Ericking@miamidade.gov

Rules

1. First come, first serve based upon the date of receipt of the entry form and the approval of the Show Directors. Note any special considerations on entry form. Deadline for Application and Fees is May 2st, 2011.
2. Miami-Dade County will not be responsible for theft, loss, damage or injury of any person or property.
3. Exhibitors must clean up their display area at the end of the Festival. All litter and packaging must be removed from the site by the vendor.
4. Exhibitors will be expected to provide their own 10' x 10' tent. If a tent is needed, the vendor can request one on their application. There will be an additional charge of \$100 for a 10'x10' tent, one table and two chairs.
5. The Park staff has the right and will execute the right to ask an exhibitor to leave if not conforming to the Park rules or for misrepresenting the nature of an exhibit. NO pets are allowed. No refunds will be made under such circumstances.
6. Educational exhibits and demonstrations that do not involve selling of materials are exempt from the vendor's fee, subject to the Show Director's approval.
7. Once reservations are made and space is assigned, no refunds will be made.
8. Cars, trucks and trailers may enter the event area at 8:00am and must be out of the Festival area before 10:00 AM, vehicles may not re-enter the grounds until 6:30 PM the evening of the Festival. Exhibitors who abandon vehicles will have their vehicles towed. There will be no exceptions.
9. Spaces are 10' x 10' and will be assigned no earlier than 2:00 PM Saturday, May 14, 2011.
10. Vendors are asked to enter the facility thru the West Dixie Entrance and obtain their Vendor passes at this location. All staff working at the vendor's booth is asked to wear their pass.
